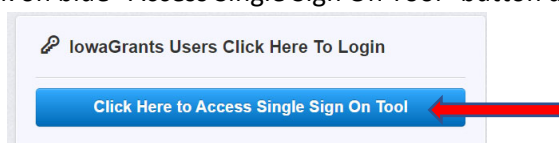


How to complete a Law Enforcement APPLICATION FOR FUNDING in Iowa Grants

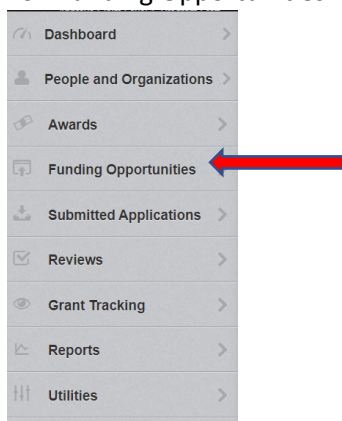
Prior to starting this application, ensure that all potential individuals who may need access to the application and/or grant are registered in Iowa Grants as users. If you need user registration assistance, please contact the Program Coordinator at 515-725-6126.

If interrupted during completion of this application and a logout occurs, click on Applications in left column, click on application title in table, click green “Edit Application” button and resume completion.

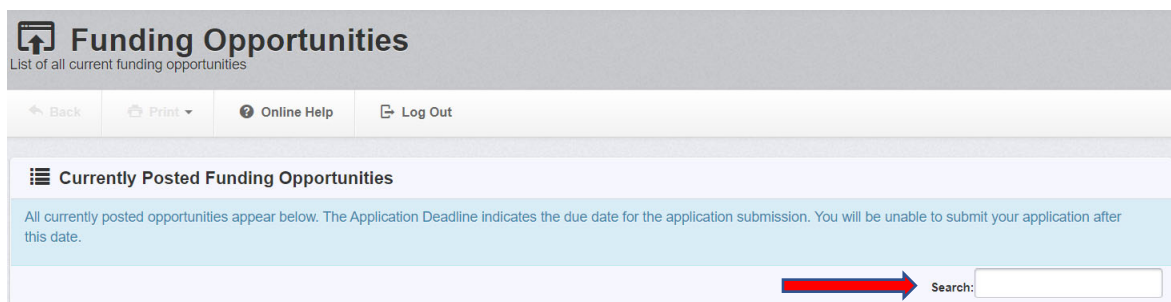
- Go to www.iowagrants.gov
- Click on blue “Access Single Sign On Tool” button and log in



- Click on Funding Opportunities in the left hand column



- In the Search field, enter **599996** and hit enter



- Click on ID Number 599996 titled 2026 GTSB LE Highway Safety Grants

- Click on green “Start New Application” button 
- Enter Application Title and confirm Primary Contact default is correct. The Primary Contact name should be that of the individual completing the application.
Click green “Save Form Information” button 
- Confirm Organization default is correct. If not, locate correct organization in drop down menu.
Then click green “Save Form Information” button 
- If application should be accessible to an additional individual within agency, click in the Additional Applicants field and select corresponding name(s) to add (only registered Iowa Grants Users will populate here). Then click green “Save Form Information” button 
- Read instructions in blue box.
- Disregard the red shaded box at this time.
- There must be a green check mark in the “Complete” column for all application components before it can be submitted.

- Click green “Save Form” button 

The next section is your opportunity to convey what traffic safety issues exist in your jurisdiction. Use this space to tell us your traffic safety story and paint a picture of your issues. You live/work there and we don't, so help educate us. Keep in mind, funding decisions are partially based on your problem statements, goals and objectives in the following three categories of Impaired Driving, Occupant Protection and Speed. Make sure to read all the provided directions and reference the provided examples to model your own agency plans.

Use data - number of crashes, number of fatalities/serious injuries

Mention specific roadways in jurisdiction - Hwy 20, Main Street, I-380, etc.

Consider information in the following table when writing problem statement, goals and objectives for Impaired Driving, Occupant Protection and Speed. The problem statement, goals and objectives entered into the application should NOT be the same for each of the above traffic safety issues. Be specific to each issue.

Problem Statement	WHO are your violators (youth, males, senior drivers, etc.) WHEN are they violating (day, night, weekends, summer months) WHERE are they violating (rural roads, highways, school zones) WHY is this happening (near bar district, in town short trips, etc.)

Goals	Broad statements of intent that provide planning, focus and vision addressing the problem statement. What change on the data listed in problem statement do you hope to have impacted by the end of the program agreement year? Reference examples provided in application instructions.
Objectives	Statements that indicate how the goal(s) will be accomplished. These statements should be SMART : Specific Measurable Achievable Relevant Time Sensitive Think of these as action steps. What needs to be implemented in order for the identified data changes (goals) to be successful? Reference examples provided in application instructions.

- Scroll down to Impaired Driving section, click green “Edit Form” button  and begin completing the information.

- Answer required yes/no question. If answer is NO, click green “Save Form” button  If answer is YES, complete the Problem Statement, Goals and Objectives

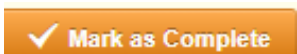

- Read instructions and information in blue boxes under LE Budget heading and Personnel Services heading.

Definitions for allowable items in the Personnel Services Item drop down menu:

Overtime for General Enforcement – dollars utilized to enforce speed and occupant protection

Overtime for Impaired Driving Enforcement – dollars utilized to enforce impaired driving

Overtime for Occupant Protection Enforcement – dollars utilized to enforce efforts of a GTSB Special Project with an occupant protection focus

Overtime for Educational Presentations – dollars utilized to present traffic safety messaging to communities (health fair, county fair, high schools, drivers education, certified child passenger safety technician activities, etc.)

Overtime for Special Projects – dollars utilized to enforce efforts of a GTSB Special Project such as nighttime seatbelt or pedestrian

Overtime for Speed Enforcement – dollars utilized to enforce efforts of a GTSB Special Project with a speed focus.

Traffic Safety Educational Materials – dollars utilized to purchase GTSB pre-approved educational brochures, banners, etc.

Training and Travel – dollars utilized to offset expenses incurred associated with traffic safety pre-approved training. The GTSB Conference does not require pre-approval.

Do not request funding in any of the highlighted categories in this application. Those funds are for specific standalone programming that is not included in this application.

- To begin requesting personnel services funds, click on green “Add Row” button 
- Complete each field then click on green “Save Row” button 
- Repeat the steps above until all Personnel Services funds have been requested.
- Read instructions and information in blue box under Equipment heading. Equipment is supplemental to enforcement. Enforcement overtime must be requested prior to requesting associated equipment. For example, if dollars for impaired driving enforcement were not requested in the application, do not request funds for an in-car camera. The camera can only be requested if impaired driving enforcement monies were additionally requested.

- To begin requesting equipment funds, click on green “Add Row” button 
- Complete each field then click on green “Save Row” button 

NOTE: You will not be able to enter a dollar amount into the field “Total Amount Requested”. Iowa Grants will automatically calculate that amount based on the information input into the Quantity field and the Maximum GTSB Reimbursement field. Make sure to reference correct reimbursement dollar amounts in the blue box.

- Repeat the steps above until all Equipment funds have been requested.
- If requesting funds for a piece of equipment not listed in drop down menu, select “Other” and then complete field titled “Other Item – Please Specify” with equipment description.
- Click on orange “Mark As Complete” button 
- Click on Comments in the Application Details component list

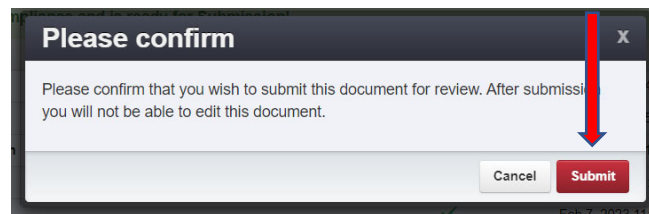
- Feel free (not required) to add any additional comments/information in the text box provided.
